A paper formatted according APA Style must: be typed on letter-sized (8.5" x 11") paper; have 1" margins (the space between the text and the edge of paper) all around the text; be double-spaced; have a legible, size 12 font (APA recommends Times New Roman, but fonts like Verdana and Trebuchet are more legible for people with visual disabilities)

Begin your References page on a separate page at the end of your research paper. Label the page References (do not italicize the words References or put them in quotation marks) and center the word References at the top of the page. Double space all citations, but do not skip spaces between entries.
