These facilities have until Nov. 29, 2019, to institute the provisions in the Revisions to Discharge Planning Requirements Final Rule [CMS-3317-F]. The final rule, published in the Sept. 30 Federal Register, gives hospitals, HHAs, and CAHs 60 days to comply. That doesn't sound like nearly enough time to put in place revised discharge planning requirements, but hospitals have had years to prepare — the proposed rule was first published in 2015.

The hospital must have an effective discharge planning process that focuses on the patient's goals and treatment preferences and includes the patient and his or her caregivers/support person(s) as active partners in the discharge planning for post-discharge care.
