Racketeering / RICO charges are very serious and typically indicate underlying crimes as well. If convicted, you may face up to 30 years in prison, so having a strong defense is crucial to your interests.

Florida Racketeering / RICO Laws - FindLaw

(1) It is unlawful for any person who has knowingly received any proceeds derived, directly or indirectly, from a pattern of racketeering activity or through the collection of an unlawful debt to use or invest, whether directly or indirectly, any part of such proceeds, or the proceeds derived from the investment or use thereof, in the acquisition of any title to, or any right, interest or ...

ORS 166.720 - Racketeering activity unlawful - 2020 Oregon ...

In most cases, sentencing guidelines suggest a range of months to years of prison time, in addition to a period of supervised release. Other sentences may call for a period of probation, or a number of hours of community service.

United States Sentencing Guidelines for Organizations

2 points are given for each prior conviction that resulted in a sentence between 60 days and 13 months. 3 points are given for each prior conviction that resulted in a sentence greater than 13 months. All the points are added up and the total is used to determine the Criminal History Category of the convicted person.

On March 20, 2018, in United States v. McCollum, Case No. 17-4296, the Fourth Circuit reluctantly held that conspiracy to commit murder in aid of racketeering under 18 U.S.C. § 1959(a)(5) is not a crime of violence under USSG §§ 2K2.1 and 4B1.2. The court first reaffirmed circuit precedent that when evaluating an inchoate offense – such as a conspiracy to commit an offense – an enhanced ...

The RICO conspiracy charge provides for a sentence of up to 20 years in prison, three years of supervised release and a fine of \$250,000. Sentences are imposed by a federal district court judge based upon the U.S. Sentencing Guidelines and other statutory factors.
